

2019 ICD-10-CM Coding Workshop Over 600 New, Changed and Deleted Codes

Based on the final ICD-10-CM code set released in June, there are over 600 code changes effective October 1, 2018 including numerous new codes that were not included in the proposed list released in April. These changes affect nearly every chapter in the coding manual!

This one-day intermediate Coding Workshop combines updated information on recent Coding Clinic Guidance and an overview of the new and changed codes effective October 1, 2018.

Focus will be on common homecare scenarios including but not limited to:

- Neoplasms
- Mental, behavioral and neurodevelopment disorders
- Nervous system disorders
- Conditions involving the circulatory system
- Diseases and complications in the digestive system
- Musculoskeletal System Conditions
- Genitourinary system conditions

Home care coders will certainly want to learn about the invalidation of the current T81.4xxD and T81.4xxS codes for post-procedural infections and the new codes proposed for post-procedural infections and post-procedural sepsis to name just a few.
