Description: The 2020 General Assembly session will come to a close just days after this conference. VAHC Executive Director and lobbyist, Marcia Tetterton will review 2020 advocacy efforts concerning requested budget amendments and final budget expectations. Although DMAS has extended the “soft- rollout” of EVV compliance until March 31, 2020 this conference will address the issues that both DMAS and the 6 managed care plans are currently seeing. At this time, claims that would be denied based on EVV non-compliance are being paid with an explanation of the error. Claim submissions that are not EVV compliant come April 1st WILL NOT be paid. Each plan will review areas of concern to help you avoid any denials because of EVV non-compliance as well as the most common denials not related to EVV. Their appeals process will be discussed in detail as well.
